

### ***Quality Control***

Quality control is the core department of our company, in which monitor and testing facility is available for bottled drinking water. This department has two laboratories one is Chemical lab and another is Microbiological lab both are full of latest equipments with professional team. They are working to monitor the quality at every step of purification process i.e. from raw water to finished product.

After every hour we check the microbiological parameters and after every batch production, the physicochemical parameters have been checked. Grab sampling technique has been adopted for the testing of 36 different physicochemical and 6 microbiological parameters.

All testing parameters has been carried out by international and national standards; US Environmental Protection Agency (EPA), International Standard Organization (ISO), American Standard for Testing Materials (ASTM), Standard Method for the Examination of water and wastewater (SMEWW) and Pakistan Standard Quality Control Authority (PSQCA). Third party monitoring has been done quarterly by PSQCA.


